This agreement is between **Calexico Unified School District** and California School-Age Consortium (CalSAC) for the implementation of the Science Action Club Project (SAC) from August 2017 – June 2018.

Science Action Club is a comprehensive science and nature learning experience designed for middle school youth in out-of-school time. The full suite of resources includes easy-to-read science curriculum guides, supplies for hands-on nature investigations, custom-configured digital learning tools, and professional development training that enables afterschool providers to offer Science Action Club in their local communities.

CALSAC AND THE CALIFORNIA ACADEMY OF SCIENCES WILL PROVIDE:

- 12 hours of professional development on the Science Action Club Curriculum:
 - One 4-hour in-person training session and one 2-hour online training course in Fall
 - One 4-hour in-person training session and one 2-hour online training course in Spring
- Curriculum and materials to implement 24 Science Action Club lessons (12 per Unit, max 2 Units)
- On-going technical assistance to support successful implementation.

EACH ENROLLED SITE COMMITS TO THE FOLLOWING:

- Designate 1-2 facilitators to participate in the SAC project from August 2017 – June 2018.
- Ensure designated facilitators attend all in-person trainings AND complete all online training courses prior to in-person training.
- Ensure designated facilitators deliver all 24 Science Action Club activities.
- Recruit and retain 15-20 youth (5th-8th grade) to participate in SAC.
- Ensure weekly collection and data entry of youth attendance via SAC Educator Portal

Cost:

A non-refundable enrollment fee of **\$3,200** for **2** clubs will be collected in two installments to confirm enrollment.
