In order to save money to the Calexico Unified School District

ASPS SECURITY Proposes (4) Security Guards per shift Approximately Cost \$ 25,280 per month, this will save the school district approximately \$ 18,960.00 per month & approximately \$ 227,520.00 per year since the school district is actually paying 7 Security guards per shift cost per month approximately \$ 44,240.00 per month and \$ 530,880.00 per year.

Total Savings per year Using (4) Guards instead of (7) approximately \$ 333,360.00.

The Security Guards will be Distributed on CUSD property as listed below.

- (1) Security officer to patrol with a golf cart the Calexico High school, District Office, Felipe Vega Facility and monitored the swimming pool with a perimeter alarm system.
- (1) Security Officer to patrol with a Mark Vehicle Patrol Unit Willi Moreno, Blanch Charles, Aurora & Mains.
- (1) Security Officer to patrol with a Mark vehicle patrol Unit Cesar Chavez, Enrique Camarena, Jefferson, Rockwood & Kennedy Gardens.
- (1) Security Officer to patrol with a golf cart De Anza & Dool.
