## **I. INFORMATION ITEMS**

### **I.1. Superintendent's Report**

Minutes:

Acting Superintendent Carlos R. Gonzales reported on the following:

Wellness Fair-He reported that the fair took place this week and over 150 employees took part in it. It was a great success. He thanked Mrs. Holloway and her students for assisting and Chef Nunez and the food technician students. He also thanked Mrs. Villegas and the Bulldogs Club for assisting.

LCAP Forums-He reported that at the community forum the district discussed goal 1 which was held at William Moreno Jr. High School, next meeting will be held on February 13, 2018 from 6-8pm at William Moreno Jr. High covering goals 2 and 3.

IVC Visioning Meeting-He attended the meeting and it allowed for him to give input in regards to IVC's strategic vision. IVC is interested in our students academically as well as the Career Technical Education pathways.

ACSA-He reported that ACSA has selected Mr. Lucio Padilla as administrator of the year. Mr. John Moreno and staff have been recognized for a model recognition as well.

### **I.2. Measure V Update**

Minutes:

Mr. Jimmy Sanders reported on the following:

He has met with the culinary instructor at Calexico High School regarding the CTE culinary arts program and he will have a full design and will bring back to the Board at the April meeting. He is working on modernization on the food service/cafeteria and will submit designs at the April meeting as well.

Modular building project is on schedule. Had a great meeting with Calexico High School administration team which was very productive. Proposing that the project is delivered with the following three contractors:

1. modulars
2. site improvement contractor
3. bid out construction/program manager

He reported that the team saw the need to create an existing teaching space and will create a document to show how the spaces are used. The document will be fluent, so that everyone understands the logistics and he will bring back to the Board at the April board meeting. On the week of February 26th soil rig will be on site.

Trustee L. Calderon asked for a timeline.

### **I.3. Prop. 39 Energy Conservation Services**

Minutes:

Ashley Cascio, Climatec representative, gave a recap on the financial highlights, construction update, and addressed the complaints by staff.

Trustee Romero stated that teachers do not leave half hour after class. He expressed his frustration with the set points. Teachers and students are paying the price and stated that he is not happy.

Trustee L. Calderon questioned what the building automation system does and also questioned what the plug management system. He would like to see Climatec representatives present while the other sites are being implemented.

Trustee Castillo questioned if the software is web-based.

#### **I.4. Association Comments (ACT/CSEA)**

Minutes:

James Taylor, ACT President, reported that ACT members have been meeting with the district regarding LCAP planning and has been very positive. It's been a pleasure to be part of the meetings and it is very successful. He thanked Mrs. Elisa Ramirez.

Temperatures are rising as far as the a/c's. They have submitted a demand to bargain and are pleased that Mr. Gonzales has reached out. He is confident a plan of progress will be in place. He stated that 39 classrooms equate to over 1300 students. We had one teacher collapse from the heat, savings will be gone if there is litigation. Imperial Unified's a/c's are set to 71 degrees and there are no issues.

He expressed his concern over the Calexico High School 9th grade campus. He stated that we have a site that is in desperate need. Calexico High School 9th grade campus is filled with exceptional teachers and they are not the issue. They have a divided principal; this is not's the principal's fault. The Assistant Principals are new and do have the tools to solve the issues. Behaviors worsen, teachers are discouraged. This site needs their own principal to ensure the safety of their students. ACT is in strong favor of having an experienced principal at that site. Finally, ACT has been made aware that the administrator on leave for sexual harassment has been on campus and visiting teachers. He questioned why this person is allowed to be on campus. He is uncomfortable knowing that he is on site. He has mentioned to this Board in the past that he has harassed other teachers, the Board needs to act. We have seen countless men who have been removed from their victims, but this man is not only getting paid but still seeks access to teachers. These are tendencies that should not be tolerated. Urged the Board to act.

Maria Fernandez, parent, stated that she is asking for help since her daughter has been bullied for the past two months. She has gone to the site and the police department. Now, her daughter got hit and she is asking for just punishment. She wants the bullying to stop. She wants a favorable response.

#### **I.5. Insurance Committee**

Minutes:

Mr. Gonzales reported that he met with the insurance committee on January 24, 2018 and he met with both unions and no concerns were expressed. He stated that our initial insurance quote came in at a 39% increase, and this rate can be negotiated. We will be going out to market and are looking to lower the rate and will update the Board. The next meeting is scheduled for Wednesday, January 21, 2018.

A wireless cloud will cover the whole community allowing them to connect. That will be growing and coming to Calexico as well. Need to continue with technology education via network and components behind it. Some board members will be visiting Tustin soon and would like to invite and share the presentation of community access. The Calexico education foundation has their annual events and he has tickets available which helps to fund student scholarships. He stressed the importance of the friendship bench and no one eats alone which took place at Blanche Charles Elementary, initiatives are important for our kids.
