Minutes:

Will Slater, teacher, stated that he is here tonight regarding the proposal. It is wrong; you should all resign your positions immediately. Mr. Taylor presented a proposal in easy language. It is not rocket science. Year three without a settlement, they have waited in good faith. We waited until the superintendent was better; your offer shows the teachers that you are not negotiating in good faith. This direction is not good for everyone. Younger teachers are looking to leave; salaries are the lowest in the valley. He questioned how could you ask a teacher to come to Calexico and not Brawley. You are elected as leaders, visionaries; everyone in this room knows who wrote the proposal. Attorneys in which you just signed a 3-year contract. If you are not man enough to think on your own, then you are a follower. Students need leaders. You don't have the right to take away the benefits in which they have given up COLA's for. The retro money is not wanted, you can keep it. COLA belongs on the salary schedule. Good faith ended when you presented your proposal. Go to fact-finding immediately. Next, is a strike. Be aware that there will be more hostile meeting, picketing in front of your houses, schools. He takes it personally, impairing all employees in supporting their families. Their families are just important as yours. You want to take from them something that was already taken in previous COLA's. You forget where you came from; remember who you came to asking for support during the elections. Insurance that we have has been protected for years. Administration pay is among the highest when teachers are among the lowest. If this is the fight you want, you will get it.

K.3. Association Comments (ACT/CSEA)

Minutes:

James Taylor, ACT President, thanked educators and parents who are in attendance. Extended gratitude to both active and retired teachers who have fought to keep our benefits. They went for a decade without a raise in order to keep health care. Teachers sacrificed, they went without, when our district was in crisis, and they sacrificed more. They took on furlough days and in return lost good educators. At this time our district is not in crisis, it is prospering. Educators across the State promoted propositions that have allowed our State to fund the districts. In fiscal abundance, the district has offered the most destructive proposal they have seen. He has requested a list of substitutes and teachers without credentials, but he has not heard from HR as of yet. He stated that in Brawley & Imperial districts they do not have any classrooms with substitutes or unqualified. El Centro district has one missing teacher. You have sent a signal to all the potential teachers; you want to take away the one thing we have to offer. You have hurt our students and their chances in having qualified teachers in the classroom. It's the law and you have broken it. He handed out a Williams's complaint to the Board. You have created a disadvantage then what was there previously.

On October 23, 2019 we should be meeting at the table, as educators we will be there to protect our students, teachers and their families. When you make a mistake as you have, you have a chance to fix this error on October 23, 2019. He hopes they take the opportunity to restore their trust and the community's trust.

Belen Donato, CSEA President, stated they are here to support ACT. They have been trying for months to start negotiations. Stop holding us up. What you do to one you do to all. United we stand.

Kim Joong, citizen, stated that he now has time to dedicate to the educational system. Students need to be promoted who will guide our teachers. Teachers are role models and mentors. Our school system does not support this. They have so many restrictions. Need to support their future. Our city government is doing a bad job as well. In the 90's the salaries were high. The teachers are not being paid well and so we cannot keep them. The budget is now double, what are you doing. Wasting the money in buildings. He tried to change the system when he was on the Board so that teachers could have more money. Something is wrong. You are not doing your jobs. He was even accused of sexual harassment when he tried to make a difference. Stop wasting our money and spend it on our teachers and school employees.
