As per the locations and the amount of buildings to cover, my **recommendation** is as follows two officers to patrol, enforcement of rules, regulations, visual, physical checks and alarm response to sites:

First officer starts at 7:30 pm to 4:30 am Monday – Thursday (All site locations)

Do the initial visual patrol of all the locations and make his or her presence known, check for any suspicious activity on properties, taking into consideration that teachers, school custodians and after school projects are in session. Till 10:30 pm

First officer weekend starts at 6:00 pm Friday to 6:00 am Monday (All site locations)

Continue visual patrol of all the locations, check for any suspicious activity on properties, taking into consideration that teachers, school activities and weekend school projects are in session.

Second officer starts at 11:00 pm to 5:00 am Monday – Sunday (will Rover all locations to overlap)

This second officer will be able to cover all sites visually and physically conducting door by door check of individual schools and will be a backup source for the primary first officer, for any alarm responses and continuous coverage of sites that would be time consuming and delaying of the patrol
